Platform Terms and Conditions

1. Introduction

- 1.1 This training and resources platform (**Platform**) is operated by Food Ladder (registered charity, ABN 89 132 323 347 (**Food Ladder, we, our, us**). By using or accessing this Platform, you agree to these terms and conditions. Food Ladder may change these terms and conditions from time to time, so you should check these terms and conditions regularly.
- 1.2 Your use of materials viewed on, printed, downloaded or otherwise obtained from the Platform, including Food Ladder's suite of written and audio visual instructional materials (**Materials**) is governed by these terms and conditions.

2. Your use of this Platform and Materials

- 2.1 You may use the Platform and any of its features and the Materials if you accurately complete monthly surveys when requested by Food Ladder. If you fail to complete a monthly survey, or if we are of the view that you have completed a monthly survey inaccurately, we may restrict your ability to use any or all of the features of the Platform and any or all of the Materials at our total discretion.

(together the "Content Standards")

- 2.3 By uploading any content to the Platform, you warrant that the content complies with the Content Standards and you indemnify us for any breach of that warranty except to the extent that we caused or contributed to that loss. We may report any breach of warranty to the relevant law enforcement authorities and we will co-operate with those authorities by disclosing your identity to them. In the event of such a breach, your right to use the Platform will cease immediately.
- 2.4 You are responsible for maintaining the confidentiality of the username and password for your Platform account.

3. Intellectual property rights

- 3.1 In this clause 3:
 - (1) Intellectual Property Rights includes any:
 - (a) copyright;

- (b) design, patent, trademark, or plant breeder rights (whether registered, unregistered or applied for);
- (c) trade, business, company or domain name;
- (d) know-how, inventions, processes, confidential information (whether in writing or recorded in any form); and
- (e) any other proprietary, licence or personal rights arising from intellectual activity in the business, industrial, scientific or artistic fields.
- (2) **System** means any and each of the
 - (a) food production system(s) or infrastructure;
 - (b) social enterprise solution(s); and
 - (c) educational program/s,

supplied by Food Ladder to You.

- 3.2 Food Ladder owns and will continue to own all Intellectual Property Rights in the Materials, except for material or content in which third parties have pre-existing Intellectual Property Rights. Any third party material or content provided by Food Ladder is provided subject to the licensing terms of the relevant third party licensor.
- 3.3 Food Ladder does not permit you to make modifications or improvements to the Materials. To the extent that you do make any modifications or improvements to the Materials, Food Ladder will own the Intellectual Property Rights in such improvements or modifications.
- 3.4 Food Ladder grants you a non-exclusive, non-transferable, revokable licence (**Licence**) to reproduce, publish, perform or communicate the Materials solely for the purpose of or in connection with:
 - (1) your use of the System;
 - (2) the provision of education or training in relation to the System;
 - (3) food production or processing arising from your use of the System; or
 - (4) any other use agreed between Food Ladder and you in writing.

The Licence will expire upon the termination or expiry of your access to the Platform.

- 3.5 The Licence is automatically suspended if you fail to complete a monthly survey, or if we are of the view that you have completed a monthly survey inaccurately. Food Ladder may subsequently, by written notice to you, either:
 - (1) revoke the Licence; or
 - (2) reinstate the Licence,

at our total discretion.

4. Privacy

All personal information that you supply in connection with this Platform will be collected, used, disclosed and managed by Food Ladder according to the terms of its privacy policy, a copy of which is available on the Food Ladder website. You consent to Food Ladder

dealing with your personal information in accordance with its privacy policy. You also agree to use this Platform in accordance with any other policies that we publish on this Platform from time to time.

5. Links

This Platform may from time to time contain hyperlinks to websites operated by third parties (**Linked Sites**). Linked Sites are not under the control of Food Ladder. Food Ladder is not responsible for, and does not control or approve, the contents or operation of any Linked Site. Your use of a Linked Site is subject to the terms and conditions of the Linked Site. Any personal information that you provide to a Linked Site will be subject to the privacy policy and practices (if any) of the operator of the Linked Site.

6. Cookies

During your use of this Platform, Food Ladder may issue and request cookies to and from your computer or mobile device. By using this Platform you authorise Food Ladder to issue and request such cookies.
